 - **A.** Council reviewed proposal submitted by Melba Gun Club regarding a lease agreement for City property adjacent to the Gun Club. Gun Club members are requesting a 50 year lease with annual payments, (to be determined). The additional property will allow the Club to remove and re-install the trap houses further away from the road way, preventing flooding that occurs during rainstorms. There will be no structures built on the additional property, the Club will allow trap shooting over the additional property.

City Attorney Gigray was unable to attend, a written response was emailed; advising Council that he does not recommend a 50 year lease, 5-10 years would be acceptable. Attorney Nichols commented a long term lease would present issues in the future. Attorney Nichols will report back to Gigray with proposed lease information. There was no action on this item.

B. City Clerk presented Tentative Budget F/Y 2017-2018 as per the June 19, 2017 Budget Workshop. After short discussion the Tentative Budget was approved with amendments to reduce Public Works shop appropriations from Water and Sewer Funds to \$10,000 each, Highway Fund \$15,000 and Capital Carryover \$14,500 (insurance payment and carryover from 2017 budget not used). Motion from Hinderliter; 2nd from Dickard. Motion Carried.

- **B.** Attorney Nichols reported for Gigray; Council may need to move forward with Quiet Title action regarding the Charlotte Dr. property. Gigray will present more information at the August 14, 2017 Council meeting. Gigray has received requested comments from City Engineer Davis and is working to complete the legal opinion for right-of-way certification regarding the Drinking Water System Improvement project.
